

CHARTER OF THE FOUNDATION CALLED CENTRUM AKTYWNOŚCI
TWÓRCZEJ (Centre for Creative Activity)
the resolution was set in 05 September 2008 by the founders

SECTION I

General agreements

§1

1. The foundation under the name of Centrum Aktywności Twórczej, was stated with authenticated deed in 05 September 2008 by:
 - Milenę Nadolną – Dróżdź
 - Marlenę Pujszę – Kunikowską
 - Szymona Kozłowskiegothey are called the founder and the authenticated deed was made by the notary Marię Bortel, who has conducted the notary office in Leszno on the Dąbrowska Street.
2. The foundation works from 16 April 1984 (the uniform text: Dz. U. Nr 46, poz. 203 z 1991 r.), on the basis of the act, as well as on arrangements of that charter.
3. The foundation is apolitical and does not belong to any religion group.
4. The foundation has a legal personality.

§2

1. The area where the foundation works is the Republic of Poland; however for its own purpose it could also work beyond the limit the Republic of Poland.
2. The foundation is located in the country- Lasocice, Leszno district, Wielkopolska County.
3. To carry out its own charter works the foundation may create the departments and the branches.

§3

1. The foundation can use the abbreviation of its name, and this abbreviation is CAT, as well when it collaborates with abroad it can make use of translation of the name in every foreign languages.
2. The foundation uses a stamp according to a design which has been approved by the Foundation Board.
3. The foundation can uses a graphical sign which distinctive it. The pattern of the sign is approved by the Foundation Board.
4. The foundation reserves the right to use the name and the graphical sign.

§4

The foundation can establish awards, honorary medals and award them with others rewards and honors to physical and legal entity for its own purposes.

§5

The foundation is set up for unlimited time.

§6

The organization which holds supervision above the foundation is the Minister of Education.

SECTION II

The purposes and rules working of the foundation

§7

1. The foundation is the organization supporter the development of the society. The foundation's purposes are to increase the activity of the local society and to support the development of children and youth.

The aims of the foundation are:

- a. To organize activities in education and upbringing range
 - b. To organize activities in culture and art range
 - c. To organize activities in attention and social assistance range
 - d. To organize activities in environmental protection range
 - e. Opposition to marginalization from the society among the youth
 - f. Support an idea to equalize youth's chances, who are in worse living position in the unseasonable society
 - g. Support the youth at taking the activities for:
 - Promotion of society life model
 - Constantly education
 - Propagation the idea of demarcation and self-government
 - h. Promotion the volunteer's idea
 - i. Activation the youth and the adults through the volunteer
 - j. Opposition of an unemployment with the particular consideration of the youths, and especially supporting the local enterprise
 - k. Taking the enterprise of the professional activity and the youths
 - l. Propagation of the information about labour market, studies, scholarships and also dealings in the country and beyond it.
 - m. Training the young leaders
 - n. Supporting a process of European integration as well as collaborate among the European organizations and others
 - o. Maintenance national and regional tradition, nursing of feeling to belong to Poland, as well as development of national, citizenly and cultural awareness
 - p. Protection the natural and cultural resources, especially heritage local societies
 - q. Supporting of the regional and local development
 - r. Contributing to the informative society development
 - s. Promotion of the sport and healthy
 - t. Promotion of ecological ideas
2. to gain the constitutional aims the foundation will occupy:
 - a. leading informative, educational and popular work and also research range of the foundation aims

- b. organizing the trainings, workshops, and also international study visits
- c. supporting any staff's and volunteers' activities working in the foundation
- d. organizing and also leading lectures, symposiums, workshops, conferences, scientific studios and also courses, which jobs are passes on the knowledge
- e. leading a citizenly guidance as an independent services, which supporting social and professional independence of citizens, especially youth
- f. advocacy in dealings of marginalize by the society
- g. initiating and organizing charity actions, for example by auctions, exhibitions, vernissages and shows
- h. organizing the lottery and fund-raising for the foundation
- i. organizing festivals and also single concerts
- j. interchange with experiences in range of the constitutional activities of the foundation
- k. promotion in the mass media the aims of the foundations
- l. the collaboration with physical and legal people as well as with the units of the autonomy and government administration, and non-governmental international and external organizations, which activities combine with a mission of the foundation
- m. realization the public activities according to the foundations' purposes
- n. making useful funds and particular useful funds, which purpose is in accordance with the mission of the foundation
- o. professional activating and unemployment campaign
- p. leading programs and information office as well as occupational counseling
- q. leading and taking part in the environmental protection programs and also in protection of culture
- r. awarding by the scholarships, awards and donations physical and legal people, who work up and take place in the programs similar to the foundation's aims
- s. cooperating with the local societies, who works for developing the interests in publics cases
- t. the promotion of the children and youths work

§8

To reach the foundation's aims, the foundation can support the work other legal people, who is conducting the work similar to the foundation's aims.

§9

The activity of the foundation is defined in §7, 2 in subsections from a-u, and that activity may be conduct as a paid or unpaid.

SECTION III

Wealth of the foundation

§10

1. The initial wealth of the foundation constitute a founding fund in sum equal 1000 (one thousand) zloty
2. The wealth of the foundation, apart from initial wealth also form possessions gained by the foundation during its activities.
